## Notice of company transfer – Change at H-BAU Technik GmbH

Dear Sir/Madam,

I am writing to inform you of a purely formal change taking place at H-BAU Technik GmbH. H-Bau Technik GmbH ("**H-BAU**") and the Horstmann Verwaltungsgesellschaft mbH (referred to below as "**Horstmann Verwaltung**") have carried out a reorganisation under company law. This has involved H-BAU merging with Horstmann Verwaltung. Horstmann Verwaltung has taken over H-BAU and will henceforth operate under the name H-BAU Technik GmbH. H-BAU will continue to be run as before. H-BAU's merger came into effect according to civil law with its registration in Horstmann Verwaltung's commercial register.

The merger is related to changes designed to simplify the company's legal structure without making or having to make any changes to the company and its business.

With the registration of the merger, all of H-BAU's rights and duties resulting from any contractual obligations that have been agreed or are to be agreed have been transferred to Horstmann. Any currently established contractual obligations will also be taken over by Horstmann Verwaltung without the need to make changes to the contracts in question. The merging of H-BAU with Horstmann Verwaltung will therefore not lead to any changes in the contents of any contracts.

All that is new is the commercial registration number (HRB 621 306) and the VAT identification number (DE 283 922 373). There are no further changes as far as you are concerned. In particular, your usual contacts and their contact details will remain the same.
